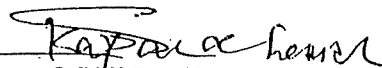

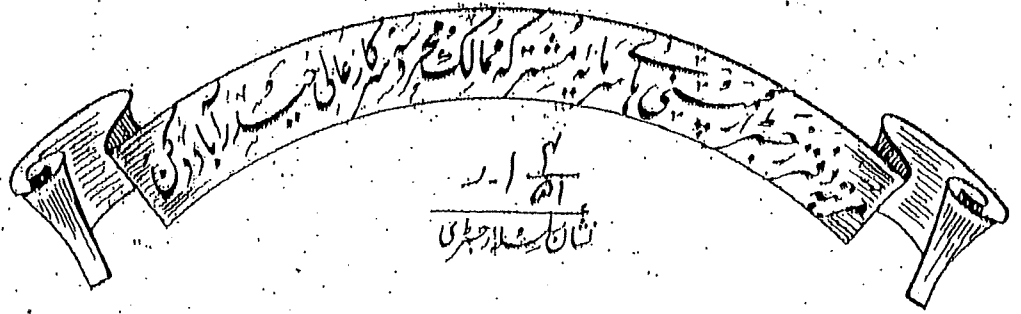

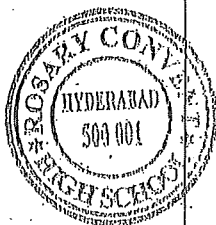

I forward herewith two sets of proposals of the Correspondent
Rosary Convent High School Hyderabad and submit that
Correspondent in her Letter II nd cited above has stated that the
Institution Established in the year 1903 and It was accorded
permanent Recognition Vide D.P.I's Pro.Rc No. 4015 dt.9-5-1950.

The Correspondent has stated that permission to open (5) Addl
section for classes I to V were accorded Vide D.E.O's Pro.Rc.No.
2289/DI/93 Dt 30-7-96 and requested the R.J.D.S.E to grant
permission and recognition to addl section VIZ ABC&D in Rosary
Convent High School.

I submit that on due verification of the proposals and documents
furnished by the management this office has found the proposals
incomplete and lacking Justification for grant of permission to
addl. section. The Dy.E.O.SR B2 in Pro.No 49/SR B2/98-99 dt 3-2-
99 has called for the detailed information based on the previous
records available with the institution in the prescribed
proforma.

The Correspondent Rosary Convent High School has furnished the
particulars and supporting documents and they were examined by me
in detail and also the proposals of management Rosary Convent
school was established by the institute of the Franciscan Sisters
of Mary in 1903 and enjoyed Temporary Recognition up to 1949 and
Permanent Recognition was accorded to Rosary Convent High School
by the D.P.I vide his Lr.No. 4015 Dt.9-5-1950.

I further submit that based on the information supported by the
documents furnished by the managment, the proposals are submitted
herewith.

1. The Education Society of Rosary Convent High School which has
A section of class / single section up to 1952-53
2. The Addl section (B) for class I to VII was opened in the year
1953 - 54
3. The Addl section C for classes I to VII & B for class VIII
opened in the 54 - 55 and B for class IX in 55-56.
4. The Addl section D for classes VI, C for class VII and B for
class X were opened in 56 - 57.
5. The Addl section D for class VII, C for class VIII in the
year 57 - 58 and section E for class VI, D for class VIIF and
C for class IX in 58 - 59.
6. The Addl section E for class VII, D for IX & C for X were
opened in 1959 - 60, and section D for X in 60 - 61.

7. The Addl section E for class VIII & IX in 61 - 62 and section E for Class X was opened in 68 - 69.
8. The Addl section opened for class VI to X from Academic year 53- 54 to 68 - 69 have economic strength as show in the col 9 statement enclosed.
9. The management of Rosary Convent High School has provided sufficient member of qualified teacher to meet the requirement of Addl. Section of classes I to X during the year 1953 - 54 to 68 - 69.
10. The management has also provided total accomodation of room for the purpose of class room for classes I to X with 5 Addl Section duly providing required furniture sanitary facilities equipment etc.
11. The management has opened Addl Section from 53-54 onwards to 68-69 without obtaining permission from the competant authorities prescribed under rules VII the A.P. Educational rules which were in existance till the A.P. Education act 1982 (Act No/ of 1982) and A.P. Educational Institutions (establishment administration and control of private schools) rule 1985 in G.O.MS.No. 60 Edn (rule) dated 28-1-86 came in to force.
12. The management of Rosary Convent could not obtain permission of the. Then Director of Public Instruction for opening of Addl Sections in classes I to X as required under rule 62 (6) of section I of chapter III of A.P.Edn rules 1966 issued in G.O.MS.NO. 1188 Edn dated 10-6-1966.
13. The Educational Society of Rosary Convent High School which has opened the Addl. Sections of BCD & E for classes VI to X between 1953 - 54 to 68-69 have also not sought permission of the DSE, as per rules 3 and 4 of G.O.MS.NO.60 Edn, dt.28-1-86. The society has submitted the proposals for permission and recognition of Addl section BCD&E opened by them vide their Lr.No. _____ Dt. _____ when the rules framed under G.O.MS.NO.(1) Dt.1-1-94 came into existance and submitted application in prescribed form I. with supporting documents.
14. The management of Rosary Convent High School has submitted a proposals to DEO for permanent recognition of Addl/Section of classes I to X in the year 92 - 93 dated 31-3-93 when the G.O. 524 dt 20-12-88 is in existance, However no final orders were issued.
15. The management has justified the opening of Addle Section on the Grounds that due to heavy pressure from the parents to admit their children in English medium schools of Missonary Management. The Addl Section were opened from 53-54 on wards to admit the students. Hence the management sought excuse for opening Addl Section in the school without prior permission from the competant authority.
16. The DEO Hyderabad has already accorded permission for opening of Addl Section ABCDE for classes I to V during year 1996 - 97 in Pro Rc.No 2289/D1/93 Dt. 30.7.96.
17. It is further submitted that the Addl Section BCD&E opened by the management for classes VI to X during the year 53-54 to 68-69 have to be considered for permission by the competant authority in terms of G.O.MS.NO. (1) Edn. Dt.1/1/94 duly ratifying the action of the management having opened the Addl Section in the school for classes VI to X without prior permission.

In the circumstances, I request the DEO to grant post facto permission of Addl section B C D and E classes VI and VII in Rosary Convent High School opened during the year 1953-54 to 68-69 onwards.
